

CHARACTERISTICS OF A GOOD VISION STATEMENT

- 1. Describes the Desired End-State, i.e., either using Present Tense (is, are) or Gerund verb (-ing, will be)
- 2. Clear
- 3. Succinct (Best statements are short and to the point)
- 4. Inspiring (Audacious, yet possible)
- 5. Specific to the Community
- 6. Long-term ~ 25 years
